

Smart Report Maker Commercial License Agreement

1. Licence Grant

Webuccino grants the Licensee a non-exclusive, non-transferable, and revocable license to install and use Smart Report Maker on a single domain owned or controlled by the Licensee, under the following conditions:

- a) The installed version of Smart Report Maker can be accessed and used by an unlimited number of users within the licensed domain.
 - b) The Licensee may modify or edit the software for their own use but is strictly prohibited from distributing, sublicensing, or selling the edited version or any derivative works to third parties.

2. Usage Restrictions

The Licensee agrees not to:

- a) Use the software in any unlawful way or for any purpose that violates applicable laws or regulations.
 - b) Distribute, sublicense, sell, lease, rent, or transfer the software or any portion thereof to any third party.
 - c) Install or use the software on more than one domain without obtaining an additional license from Webuccino.
 - d) Reverse engineer or decompile the software for any purpose other than lawful personal customization.

3. Ownership

All rights, title, and interest in and to Smart Report Maker, including its intellectual property rights, remain with Webuccino. This license does not transfer ownership of the software to the Licensee.

4. Customer Support

The Licensee is entitled to one year of customer support from the date of purchase. Support is provided exclusively through Webuccino's ticketing system. After the initial support period, the Licensee may purchase additional support as required.

5. Free Upgrades and Discounts

- a) The Licensee is entitled to free upgrades to new versions of Smart Report Maker for six (6) months from the date of purchase.
 - b) After the six-month period, the Licensee will be offered a 50% discount on upgrades to newer versions of the software.

6. Limitation of Liability

The software is supplied "as is", and all use is at the Licensee's own risk. Webuccino is NOT responsible for any damages whatsoever, including, but not limited to:

- Loss of information,
 - Interruption of business,
 - Personal injury, and/or
 - Any direct, indirect, incidental, consequential, or special damages incurred before, during, or after the use of the software.
1. Entire Liability:
The entire liability of Webuccino, without exception, is limited to reimbursing the customer for the purchase price of Smart Report Maker (not exceeding the amount paid by the Licensee) in exchange for the Licensee removing the product from their servers.
 2. No Liability for Damages:
Under no circumstances shall Webuccino be liable for any direct, indirect, incidental, consequential, special, or exemplary damages arising from or relating to:
 - This agreement,
 - The software, or
 - The Licensee's use or misuse of the software, including damages incurred by third parties.

This limitation of liability applies whether damages arise from errors in the software, its misuse, or any services provided by Smart Report Maker.

7. Termination

This license is valid until terminated. Webuccino reserves the right to terminate this agreement immediately if the Licensee violates any terms of this agreement. Upon termination, the Licensee must discontinue use and delete all copies of the software.

8. Acceptance of Terms

By purchasing, installing, or using Smart Report Maker, the Licensee agrees to all terms outlined in this agreement.
